1. Minutes of the April 20, 2022, meeting

2. Chairperson's Report - Clare Martin

- Clare noted that the Watershed Alliance AGM will be held on May 28; no pre-registration is required this year.
- Clare shared comments we received from the Program Officer for the Eco-Action Program in the Atlantic Region and Québec following the submission of our report on last year's work. There were positive comments on the number of trees planted; our hiring and training practices for students; our collaboration with the provincial government in data sharing; and the fact that Sarah was able to find additional funding mid-project.
- Sarah will follow-up with Todd Dupuis on an unresolved issue from the meeting of the Water Committee and with Councillor Doiron regarding the grant request to the City Water and Sewer Utility.
- The Lady's Slipper Walk is scheduled tentatively for Saturday, June 11 at 10:00 am with an alternate date of June 18. John will lead the walk and welcome hikers at his cabin as in years prior to COVID. Summer staff will help with logistics.
- Clare reminded Board members of her request for feedback on mileage rates for staff.

Sarah reported that most summer positions have been filled but that we're still looking for two people.

8. Review of the Scorecard

- Sarah will present the 2021-2022 scorecard to the AGM as part of the Coordinator's Report.
- We still must set objectives for most priorities for 2022-2023.

9. AGM Update

- Members reviewed and approved the agenda.
- Clare explained that we had to select a different guest speaker than what had been proposed because Dr. Sarah Stewart-Clark was unavailable. Scott Anderson, Coordinator of the Living Laboratory will speak on "Agricultural Climate Solutions Using the Living Labs Approach".
- Matt agreed to oversee the election, if required.
- Clare is looking after the gifts for the guest speaker and retiring members.

10. Next Meetings

- Following the AGM, a meeting will take place, tentatively on June 1, to elect members of the Executive.
- The next regular monthly meeting is scheduled for June 15.
